A. With this Amendment, the GST© Virtual Bank ACT 08-30-2020 act is ratified IN TOTO and the following it is amended and integrated:

1. GST© Virtual Bank is an acronym for GIANGIACOMO SAVOGIN TRUST© Virtual Bank;
2. The annual digitalized transfer of funds available to the population for the Res Publica can also take place through CDP (Cassa Depositi e Prestiti) S.p.A. VAT number 07756511007 (retroactive amendment to January 1, 2021);
3. Full restoration of the Italian Constitution with the perennial repeal of articles 32, 53, 59, 68, 69, 78, 90, 119, 138;
4. The mandate to the Regional Councils for the management of the Commissioning in the territory managed by them (Regions) is ratified, in agreement and with the active participation of the Prefectures, Provinces and Municipalities pertaining to their territory.
