2. On October 24, 2012, the True Bill WA DC Doc. # 2012114776 was resigned in UCC, with which the constitution of the banking system is canceled (unrebatted);
3. On November 28, 2012, the Declaration of Fact Doc. # 2012127914, by which the constitutive acts of governments are annulled, was recorded in the UCC (unrebatted);
4. The Italy State, as well as the BIS, the ECB, the EBA and the KMPG, adopts and accepts the practice by which commercial banks create a scriptural currency in the granting of loans and payments (thus making a taxable, though not accounted for and therefore deducted from taxation); the Bank of Italy, in Carmelo Barbagallo's position, Chief Inspector of the Supervision, thus responded to a question from the Honorable Alessio Mattia Villarosa, in the Joint Chamber-Senate Finance Committee, of 01.17.17: <http://iassem.blogspot.it/2017/03/forensic-evidence-risposta-della-banca.html> - so the practice

The faculty of non-central banks to create scriptural Euro in the absence of any statutory law granting them this option is recognized on the principle that what is not forbidden or reserved, it is lawful. On the basis of the principle of equality, sanctioned by art. 3 of the Italian Constitution and Art. 1, 2, 7 of the Universal Declaration of Human Rights of January 10, 1948 (ratified by Italian Law 881 of 1977), this principle applies to all subjects; therefore everyone, not only banks, can create trust money denominated in Euro, while simple issue of pre-existing funds is normative and limited to the holders of legal requirements;
